Invitational Format

CLASS CONDUCT

- a. Athletes will compete on not less than two horses during the competition. During the rail work phase athletes will work at the walk, trot, and canter (5-Gaited may include slow gait and rack depending on horse availability) both directions of the ring. The competition manager and USEF staff liaison will divide athletes into groups of sizes deemed manageable with regard to the horses being used for the competition.
- b. Patterns will be executed individually by each athlete on a minimum of two different horses. The patterns to be performed will be divided into segments, each of which will have an assigned score. Copies of the patterns approved by USEF will be distributed to the athletes at the drawing of the horses. The order of go for the patterns shall be determined by a draw, to be conducted in conjunction with the draw of horses.
- c. Coaching of the riders will be allowed during the rail phase of the competition, but there will be no during the pattern work. This rule includes both instructors and members of the audience. This rule will be STRICTLY ENFORCED. Violations of this rule could result in the elimination of an athlete and/or the expulsion of the person doing the coaching from the arena area. The decision of the USEF Steward, in consultation with the competition manager and/or the judges attending shall be final.
- d. Rides will be scheduled by the competition manager and USEF staff liaison as deemed appropriate. The athletes' ride schedules will be given to them at the same time the draw is conducted. Breaks will be scheduled during each day's events. Should time restraints require any adjustments to the set schedule, such changes will be announced by the official Event Announcer as far in advance as possible.
- e. Competitors will be allowed two five-minute time outs for breakage of equipment or a cast shoe during the competition. If in the second time out a successful repair/shoe replacement cannot be satisfactorily achieved, an emergency alternate horse and/or equipment may be substituted by the host. At the conclusion of the allotted time, the athlete must proceed on either the same horse, the emergency alternate, or withdraw from that phase of the competition. An athlete who withdraws will not receive a score for that phase of the competition but may continue in the next phase they are entered.

SCORING

- a. RAIL: Rail work will be evaluated using a numerical system based on a perfect score total of 100 from each judge.
- b. PATTERN: Each pattern will be divided into segments, which will carry possible score values as determined by the panel of judges prior to the competition. Each pattern will have a total possible score of 100 points from each judge, resulting from the combined total of the segment scores.
- c. ORDINAL CONVERSION: The numerical score given by the judges for each athlete at the conclusion of each phase (with phase defined as a railwork, or pattern) will be converted to an ordinal, with each judge's highest numerical score converting to a '1', the next highest a '2', etc.
- d. Numerical scores for each ride of every contestant will be announced at the conclusion of the ride with the exception of the final rail ride scores. These scores will only be made public following the announcement of the Medal winners at the Awards Ceremony.
- e. The lowest raw score (not lowest ordinal) from each team will be dropped at the conclusion of each combined phase (rail and pattern).
- f. The grand total score for each team shall be a combination of the ordinals awarded by all judges from all railwork and patterns, minus the lowest raw score for each team as indicated above. The team with the lowest total ordinal score will be named the Gold Medal Winners, with the next lowest Silver and next lowest Bronze.
- f. In the event of a tie, preference will be given to the athlete with the lower combined rail ordinal scores from all judges. If a tie still exists, preference will be given to the athlete with the lower combined pattern ordinal scores from all judges. If none of the above methods are sufficient to break the tie, the lower combined total ordinal scores for the railwork and pattern segments of the competition as issued by ONE judge determined by the Committee to serve as the Referee shall have precedence. The referee shall be announced prior to the start of the competition, generally at the event where athletes draw for horses, order of go, etc.

JUDGING

- a. The athletes are to be judged 50% on rail work (25% each on two rides), 50% on patterns (25% each on two patterns).
- b. Athletes will be scored by a panel of three judges. Judges shall be selected from the current United States Equestrian Federation, Inc. Licensed Officials list and/or the Riding Horse Judges Association of South Africa. In the event that a judge is unable to begin or complete the scoring of the entire event, it shall be the right of USEF and/or the competition manager to amend the number of judges or utilize substitutes. Every effort to maintain the integrity of the scoring and the fairness of the competition will be made in such case.
- c. Judges will use the standards from Subchapter EQ-3, Saddle Seat Equitation, in the Federation Rule Book as their guideline for evaluating each athlete. The scoring used will be a numerical system for all phases and the scores will be announced and posted with the exception as noted above in "Scoring". The scoring system to be used will be explained in depth to each judge before the start of the competition. Judges may only call for tests 1-13 (see EQ119.1-13).
- d. Judges should analyze each athlete's form as well as his/her horsemanship abilities while keeping foremost in mind the unusual demands of the Invitational competition itself. An athlete's resiliency after a "rough" class should also be given due consideration in the scoring. The format for the Invitational, which requires competitors to ride horses which they have little or no familiarity*, was specifically designed to parallel the premise of the International event conditions. Further, the format is designed to give judges the opportunity to evaluate each athlete's ability to respond to these unusual demands. [*Due to the nature of the horses often being donated for the competition, it is possible athletes may have ridden some of the horses used for the Invitational. Thus, the Committee will observe the ISSEA rules that an athlete may not compete on a horse that he/she has previously owned or exhibited. In cases involving other types of familiarity, the competition manager and USEF staff liaison will make every effort to ensure there are no significant advantages given to athletes who may have had experience with horses used in the Invitational. Such measures may include, but are not limited to procurement of additional donated horses approved by USEF for the duration of the competition.

ALTERNATE ATHLETE STATUS

The alternates for each team are considered “on call” to replace any member of the Team who may need to be replaced prior to the official start of the Invitational. Alternates will be recognized during any awards ceremony.

AWARDS

The event will conclude with the announcement of the Bronze, Silver and Gold Medal winning Teams. Medals will be awarded to each team member accordingly.

FEES AT THE INVITATIONAL

- a. The Federation Fee of \$15 will be waived for the World Cup Selection Trials. Chapter GR4, Drugs and Medications, will remain in effect.
- b. USEF Membership and Non-Member fees will not apply to owners of donated horses; or the rider and coaches from other countries.

RESOLUTION OF ISSUES

All matters arising in connection with the execution of the Invitational competition that are not specifically addressed herein shall be subject to the jurisdiction of the USEF and William Woods representatives and resolution of all matters shall be final.

RULES AND GENERAL INFORMATION

1. The 2013 US SADDLE SEAT Invitational is covered by the 2013 rules and specifications of the current USEF Rule Book and will be conducted and judged in accordance therewith.
2. STABLING: Permanent stalls are of wood Construction 10'x10' with permanent doors.
3. DOGS ARE NOT PERMITTED ON THE GROUNDS OF THIS COMPETITION.
4. PARKING: All vehicles must be parked in designated parking areas. Access roads adjacent to the barns are for loading and unloading only!
5. MOTORIZED VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
6. ARENAS: the warm-up and indoor arena contain sand footing
7. PRIZE MONEY: NO PRIZE MONEY WILL BE AWARDED
